News:

New Steering Committee Members - We are delighted to announce new members to SHAW's steering committee to start in January 2024.

Chair: Dr. Olivia Wright (Leeds Beckett University)

Olivia is an interdisciplinary scholar of the United States, and her research explores how different communities have historically used cultural tools and artistic expression to navigate and theorize various manifestations of confinement—both physical sites, such as prisons, psychiatric facilities and reformatory schools, and the various racial, gendered, and socioeconomic confinements that impact upon society more broadly. Her current book project, *Caged Sister: Women's Prison Zines in the United States*, is the first study to collect, analyse, and theorise the long history of collective writing from women's prisons, and is grounded in an analysis of over fifty different publications and 1,000 individual issues gathered through original archival research. Olivia has some wonderful ideas for SHAW, including expanding SHAW's reach into Europe, and starting a new mentoring scheme for scholars at various points in their career.

Co-Secretaries: Dr H  l  ne Charl  ry (University of Toulouse Jean Jaur  s) & Dr Rach  ll S  nchez-Rivera (Cambridge University)

H  l  ne specializes in American Studies and Film and Television Studies. More specifically, her recent research has focused on contemporary Black women filmmakers, aesthetics, and distribution strategies. Her research is grounded on the theoretical background developed by the Black feminist scholarship. H  l  ne brings a wealth of experience to the role and will help expand SHAW's reach into Europe and help to cultivate existing and new connections.

Rach  ll's interests lie in Eugenics, Racism, Reproductive Justice, Historical Sociology, Sociology of Health and Illness, Critical Race Theory, Disability Studies, Gender, and Queer/Cu  r Theory. Her first book, *What Happened to Mexican Eugenics: Racism and the Reproduction of the nation* is currently under review with Cambridge University Press. Her current project focuses on *The Cultural Politics of Reproduction in Latin America* (alongside Dr. Rebecca Ogden, University of Kent). Rach  ll is a tech guru and plans to record some / all our seminar series and make them available on YouTube to further broaden our reach.

BrANCA (British Association of Nineteenth-Century Americanists) have launched an exciting new **mentoring scheme for Early Career Researchers and postgrads** in the UK and Europe working on the long American C19 (both American and C19 broadly conceived). In this scheme, a member of the Steering Committee will read over and provide detailed feedback on a piece of writing (up to 8,000 words) that will in future be submitted to a peer-reviewed journal. The aim will be to make the article as robust as possible; and to expand the network of readers for it. BrANCH (British American Nineteenth Century Historians) have launched a **Voluntary Mentorship Scheme**: “In an aim to try to help diversify higher education and encourage those from underrepresented backgrounds across the spectrum (whether that is BAME, working class, female, first generation, etc.) to become historians of the nineteenth-century US, BrANCH have decided to create an informal mentorship scheme. We have created this for anyone starting out in academia (broadly defined as MA and PhD students, and some ECRs if they would like) who feel they would benefit from the guidance or advice from a mentor. Dr Marie Molloy

Marie is a Senior Lecturer in American History at Manchester Metropolitan University. Her research examines race, class, and gender in the nineteenth-century American South. Her first monograph examined *Single, White Slaveholding Women in the Nineteenth-Century American South* (University of South Carolina Press, 2018) and her co-edited book with Dr Laura Sandy, *The Civil War and Slavery Reconsidered: Negotiating the Peripheries* was published in 2019. She is currently working on a book length project on adultery across the colour line in the slaveholding south. Dr. Molloy is a passionate advocate of equality, diversity, and inclusion, and in her role as the History, Politics and Philosophy Lead for Schools and Widening Participation, she has organised several conferences and events for secondary schools on these themes. She is also book review editor for *Women's History Review*.

is a Senior Lecturer and Staff Tutor in the Department of History at the Open University, Milton Keynes. She has spent most of her career teaching US and broader American history, especially around the themes of race, gender and political change in the nineteenth and twentieth centuries. Broadly speaking, she is a historian of the period we like to call 'The Sixties', with a focus on developments in the United States. Her current project considers life writing by women activists within the Civil Rights and Black Power movements. How does writing one's own story allow women to assert control over, and subvert, narratives of the past? How do these women shape their stories for a public audience? How do these stories act as extensions of protest and activism? She first joined SHAW in 2011, and became a member of the steering group in 2013. She has held the positions of Secretary and Chair, and is now the Treasurer.
